

# Chancellor, SD Corn Discount Schedule

## Discounts effective Sep 13, 2023.

## **Test Weight**

1 cent per bushel per pound below 54.0# 2 cents per bushel per pound below 53.0# 4 cents per bushel per pound below 50.0#

## Below 50.0# Test Weight

At discretion of Commodities Manager Higher discounts per point will apply. Loads may be rejected.

53.9-53.0# = 1 cent 52.9-52.0# = 3 cents 51.9-51.0# = 5 cents 50.9-50.0# = 7 cents 49.9-49.0# = 11 cents 48.9-48.0# = 15 cents 47.9-47.0# = 19 cents 46.9-46.0# = 23 cents

## BCFM - Foreign Material (FM) or Broken Corn (BC)

2 cents each 1 % from 4.1 to 5.0 % 3 cents each 1 % from 5.1 to 7.0 % Over 7 %: At discretion of Commodities Manager. Higher discounts per point will apply. Loads may be rejected.

# NOTICE: POET – Chancellor No-Shrink Benefit

Producers will be paid on wet bushels. No shrink will be taken!

## <u>Moisture</u>

15.6-16.0 % = 5.0 cents16.1-16.5 % = 10.0 cents16.6-17.0 % = 15.0 cents17.1-17.5 % = 20.0 cents17.6-18.0 % = 25.0 cents18.1-18.5 % = 30.0 cents18.6-19.0 % = 35.0 cents19.1-19.5 % = 40.0 cents19.6-20.0 % = 45.0 cents20.1-20.5 % = 50.0 cents20.6-21.0 % = 55.0 cents

Acceptance of over 20 % moisture is at the discretion of Commodities Manager. Loads may be rejected. Higher discounts per point will apply.

Loads above 3 % will be rejected.

## **Damage**

Up to 5 % - No discount Over 10 %: At discretion of Commodities Manager. Loads may be rejected. Higher discounts per point will apply.

5.1-6.0 % = 2 cents 6.1-7.0 % = 5 cents 7.1-8.0 % = 8 cents 8.1-9.0 % = 11 cents 9.1-10.0 % = 14 cents

## **Other Restrictions:**

1. Maximum of 3 % of other grains or soybeans allowable per load.

2. Corn that is found to be musty, moldy, heating, sour or possessing a commercially objectionable foreign odor (COFO) may be rejected. Corn must meet all FDA and/or USDA fumigation requirements. 10.0 cent/bu discount if accepted.

3. Corn containing two or more live weevils, or 10 or more other live grain-storage insects/1000 grams will be rejected. 10.0 cent/bu discount if accepted.

4. Aflatoxin levels over 6 ppb may be rejected.

Consult Commodities Manager and Quality Manager.

5. Corn containing rodent or bird contamination, stones, glass or other commercially undesirable FM will be rejected.

Additional charges: South Dakota Corn Association check-off of 1 cent/ bushel will be deducted.
